

## PGW Publishers' Transition to Perseus Continues 8/1/07

Effective **August 1st 2007**, an important Vendor of Record change will occur. The subsidiary currently known as Transition Vendor aka Publishers Group West (PGW) will take the final steps towards transitioning distribution of participating publishers to Perseus Books Group. For publishers who were with Transition Vendor and have now signed distribution contracts with Perseus, the new Vendor of Record will be Perseus Distribution. Details are outlined below.
